

Scope of the Problems:

- Most major incidents are in 6 provinces.
- 5.18 million people in 6,422 villages affected by mines/ERW. (The Landmine Impact Survey of May 2002)
- New mine/ERW casualties in 21 of the 24 provinces.

Ratified the Treaty on 28 July 1999.






1 - LM/ERW Casualies and Data Collection

- Sharp decrease in 2006. (≈ 50%)
 source CMVIS.
- Study on causes of the decrease and final report is in process.
- Survey on services provided to victims is on the way... by CMVIS (Feb 07)



2-Emergency and Con't Med Care

- Immediate Assistance: CFDS, CRC, JS & CMVIS
- Emergency hospital: Free surgery, also 5 First Aid posts in Samlot (BTB)
- Transport: CMAC, Halo Trust, MAG, JS and CFDS as part of their overall program.
- Training in Emergency: Norwegian NGO TCF, CRS and CARE.





DAC

- 11 Centres: by HIB, HIF, ICRC, CT and VI.
- Others: CTF, OEC...
- Between 1991 and 2005,
 72.8% of the registered at 6
 Cnt were LM survivors.
- There are 216 PTs. 10 to 20 graduates each academic year from CT-CSPO.

 - MoSVY, DAC, ADD, CDPO,



- Gov't: US\$100K in 2005 and again 2006.
- CMAA and MoSVY Chair and co-chair the Committee.
- MoSVY with DAC and other 5 PR iNGOs (HIB, CT, HIF, CT, and VI) completed a PRC Evaluation in October 2006. (supported by Unicef, AusAID, EU)



- MoSVY 2006 started working on coordinate Nat'l CBR and Disability Awareness Raising.
- MoSVY-CMAA (and other Ministries will this year) deeply involve in the Develop't of VA National Plan of Action.



DAC

- 89% of PwD reside in rural areas.
- The average monthly wage for rural disabled HoHs, for example, is
 ≈ US\$22/month.

Constraints...

- Accessibility (centre, building, info....)
- Expensive medical care...
- Lack of Funding
- Lack of coordination...
- Gov't human and financial resources



SMART...





SMART targets...

- By the end of 2007: A National Plan of Action in place. (to be reported at the 8MSP)
- By Q1 of 2008, establish the following Working Groups:
 - Information & sector data WG;
 - Psychological Support WG;
- By 2010, MoSVY able to coordinate CBR and Vocational Training Activities themselves;



To be presented to VA SC ...

- By 2009, Provide Training in Psychological Support to the following:
 - Nurse; Social Workers, Data collectors, in the 6 provinces;
 - By 2009 Working with CRC, to provide more First Aid and Emergency Training Provided to in the 6 provinces;
 - By 2012, More Emergency / Medical Care in other 5 provinces;



Expectation...

- Disability Law adopted by the end of 2007;
- Gov't ratifies UN Convention (of the Rights of PwD) by the end of 2007;
- By 2009, Government facilitates free medical care to LM Survivors;
- MoSVY staff capacity by 2010;
