#### Disability Inclusion: How are we doing as a sector?

# Digital Innovation: Promoting Improvement, Sustainability and Ownership through databasing National Mine Action Standards – launching the Afghanistan mineaction.net application

Host: United Nations Mine Action Service

This event will demonstrate the first application of the mineaction.net database tool to a set of National Mine Action Standards (NMAS) in Afghanistan. Panelists will discuss the opportunities of digitally linking the Afghan Mine Action Standards (AMAS) to the International Mine Action Standards (IMAS) and will discuss the opportunities in supporting standards compliance and improved operational processes. The event will also illustrate the use of a semi-automated 'smart' updating system to help the AMAS to stay up to date with IMAS, directly supporting the efforts of States Parties to address Action #5 of the Oslo and Action #6 of the Lausanne Action Plans. The integrated system supports continual adoption of best practices, will promote ownership by national authorities and exit strategies for capacity development partners.
