# Technical survey, continuation

- ▶ Region 7 regions
- ▶ Type of contamination Mines + UXO/AO
- ▶ Justification
  - ▶ Chad commitments under the Ottawa
  - ▶ Risk reduction, removal of the constraints on socio-economic development
- ▶ Objectives
  - ▶ National-scale impact survey
  - ▶ Exact identification of the contaminated areas and the affected communities
  - ▶ Operations planning (resources, cost, timeframe)
- ▶ Means
  - ▶ Technical survey and clearance capacity
  - ▶ Technical and institutional support
- ▶ Budget: US\$ 2 563 968 (12 months)
- ▶ Status:
  - ▶ Survey launched in 2010 (UNDP / Japan)
  - ▶ Funding required to ensure the continuation of the operations in 2011 - 2012

# Capacity strengthening

- ▶ Region National
- ▶ Justification
  - ▶ Chad commitments under the Ottawa
  - ▶ Risk reduction, removal of the constraints on socio-economic development
- ▶ Objectives
  - ▶ Strengthening national mine action capacities, focusing on the completion of the obligations related to the Ottawa Convention. Technical assistance, vocational training and institutional support to the national demining center, covering key sensitive domains: strategic planning, operations management and coordination, quality control, database management and reporting.
- ▶ Means
  - ▶ Technical, operational and institutional support
- ▶ Budget: US\$1 613 535
- ▶ Status:
  - ▶ Contribution for 4 months mobilized (UNDP / Canada, DFAIT)
  - ▶ Funding required to ensure the continuation of the operations in 2011 - 2012

# Clearance, continuation

- ▶ Region Borkou, Ennedi
- ▶ Type of contamination Champs de mines mixtes AP/AC
- ▶ Justification
  - ▶ Opening access to roads and tracks
  - ▶ Access to land pasture and water points
  - ▶ Removal of the constraints on socio-economic development projects
- ▶ Means
  - ▶ Clearance teams with mechanical capacity
  - ▶ Logistics, material and equipment
  - ▶ Technical and institutional support
- ▶ Budget: US\$ 3 135 968 (for 12 months)
- ▶ Status:
  - ▶ Operations launched in 2010 / 2011 (UNDP / Japon ; CND / Libya )
  - ▶ Funding required to ensure the continuation of the operations in 2011 - 2012

# Clearance & quality control, mechanical capacity

- ▶ Region Borkou, Ennedi
- ▶ Type of contamination Mines and ERW (UXO/AO)
- ▶ Justification
  - ▶ Supporting survey and clearance operations
    - ▶ Technical survey
    - ▶ Area reduction
    - ▶ Clearance
- ▶ Means
  - ▶ Combined survey & clearance teams with mechanical capacity
  - ▶ Logistics, material and equipment
  - ▶ Technical and institutional support
- ▶ Budget: US\$ 1 560 000
- ▶ Status: I<sup>st</sup> phase ongoing
  - ▶ Deployment phase of a mechanical capacity for quality control (Wadi Doum)
  - ▶ Additional funds required to extend the capacities

# UXO Clearance

- ▶ Region Wadi Fira, Ouaddai et Salamat (Sud-Est , Est)
- ▶ Type of contamination ERW – UXO/AO
- ▶ Justification
  - ▶ Access to land pasture, water points and infrastructures
  - ▶ Removal of the constraints on recovery and socio-economic development projects
- ▶ Means
  - ▶ EOD teams
  - ▶ Quality control teams
  - ▶ Logistics, material and equipment
  - ▶ Technical and institutional support
- ▶ Budget: US\$ 2 133 263
- ▶ Status
  - ▶ UXO clearance operations carried out in 2008 / 2009 (European Union, CERF UN OCHA)
  - ▶ Operator Mines Advisory Group (MAG)
  - ▶ Funding required to launch new operations
