Background:

- The Convention states that "if a State Party believes that it will be unable to destroy or ensure the destruction of anti-personnel mines (in mined areas under its jurisdiction or control) within (ten years after the entry into force of the Convention for that State Party), it may submit a request to a Meeting for the States Parties or a Review Conference for an extension of the deadline for completing the destruction of such anti-personnel mines, for a period of up to 10 years."
- Logically, a State Party's request should be considered at the Meeting of the States Parties or Review Conference prior to that State Party's deadline.
- In addition, at the September 2006 Seventh Meeting of the States Parties, it was agreed "to encourage States Parties seeking Article 5 extensions to submit their request to the President no fewer than nine months before the Meeting of the States Parties or Review Conference at which the decision on the request would need to be made."
- As of September 2006, 45 States Parties had indicated that they were in the process of fulfilling Article 5 obligations. Many of these may need to submit a request for an extension.
- Given that the Convention entered into force for different States at different times it may be confusing for States Parties regarding when they should submit a request for an extension and when such a request would be considered.
- To assist States Parties which may need to submit a request for an extension, the Co-Chairs of the Standing Committee on Mine Clearance, Mine Risk Education and Mine Action Technologies have prepared the following calendar.






