Introduction

The Standing Committee on Victim Assistance and Socio-Economic Reintegration has made significant progress in achieving its mandate to identify practical means to assist States in meeting their obligations under Article 6.3 of the Convention. This is due in large part to the leadership of the past Co-Chairs as well as the various inputs of individual States Parties and non-governmental and international organizations. Aside from the important exchanges of information during each meeting, the Standing Committee has made a difference by articulating agreed principles on matters such as the definitions of "landmine victim" and "victim assistance", and the relationship of victim assistance to broader health care and disability issues. In addition, the Standing Committee has done an admirable job in promoting discussions on best practices and in undertaking initiatives such as the "Raising the Voices" project and the identification of focal points.

Looking to the future, the challenges faced by the Standing Committee are vast in continuing to make an effective contribution to helping States Parties fulfill their obligations under Article 6.3. The field of victim assistance is extremely broad, with many elements, participants and diverse linkages into other areas such as health care, economic and social development, and human rights. There is no shortage of opportunities to act. However, in order to ensure that the work of the Standing Committee remains relevant, effective and efficient, there is a need to focus efforts and ensure that the Standing Committee has direction. By the time of the 2004 Review Conference there will be an expectation that progress will have been made. Therefore, the Co-Chairs would be grateful if meeting participants could give due attention to: identifying concrete progress that can be made by 2004 and beyond; sharing relevant ways and means that this progress can be made; and, identifying the Standing Committee's particular role in contributing to this progress.

Structure of the Agenda

The agenda has been loosely broken down into three types of agenda items. First, the meeting is scheduled to begin with an overview of recent efforts to promote both the ongoing effectiveness of the Standing Committee and a particular methodology and process for making a difference in affected countries. Second, presentations will be made to share with meeting participants important information on the state of victim assistance around the world. Third, an opportunity has been provided for discussions on various categories for action that have been identified and used by organizations like the ICBL Working Group on Victim Assistance and Handicap International.

However, the Co-Chairs are also cognizant that some meeting participants may wish to intervene on matters that do not appear on the agenda.
