# INITIAL IDEAS CONCERNING, AND SUGGESTED AGENDA AND PROGRAMME FOR, THE SEVENTH MEETING OF THE STATES PARTIES

# President-Designate (Australia) Revised 11 May 2006

#### **Priorities for 7MSP**

The Seventh Meeting of States Parties (7MSP) represents another important milestone in measuring States Parties' progress in implementing the Mine Ban Treaty. The meeting provides an opportunity to reflect on steps taken since the Sixth Meeting of the States Parties (6MSP) to apply the Nairobi Action Plan, as well as to discuss upcoming challenges, as we move towards critical deadlines and the Second Review Conference.

At the 7MSP, Australia would like to place an ever greater focus on the biggest challenges facing the Convention, namely implementing mine clearance obligations and providing assistance to victims. To this end, we propose to reorder the agenda and work program accordingly (see attached documents).

In planning thematic discussions on these two issues, Australia will work closely with Co-Chairs and Co-Rapporteurs of the relevant Standing Committees, to follow-up and <u>build on the work undertaken</u> at the May Intersessionals. With regard to mine clearance, Australia will support efforts of mine affected and donor countries to ensure that mine clearance deadlines are met. On the question of victim assistance, we will support efforts to build comprehensive national plans in the twenty-four countries with the largest number of survivors. Australia encourages the active participation of survivors at the 7MSP.

As an outcome of the meeting, Australia will produce a short 'Geneva 2006 Progress Report', which will capture the progress made in implementation since the 6MSP.

## **Organisation of meeting**

The amount of time actually used at the 6MSP demonstrates that it is possible for the 7MSP to stage an opening ceremony the morning of the first day of the meeting rather than the night before. We therefore plan to hold the <u>opening ceremony on Monday 18 September</u>, followed immediately with the official opening of the meeting.

A successful feature of the Zagreb 6MSP was the decreased amount of time used for general statements relative to previous MSPs. At the 7MSP, States Parties and observers will again be discouraged from delivering statements of a general nature. States Parties and observers wishing to exercise their right to speak during a general exchange of views should limit their statements to five minutes. Australia will also follow the example of the 6MSP and institute a rolling list of speakers for the entire conference.

We propose that we take advantage of the time allocated for the 7MSP to conduct <u>informal and interactive discussions</u> on key thematic issues during the week. A 3-hour time-block would be set aside for this purpose. This could be used to discuss questions raised in the May Intersessionals and pressing issues facing the Convention.
