MONDAY 29 NOVEMBER

10:00 - 11:00

Opening ceremony

An opening ceremony will feature the participation of the Ministers of Foreign Affairs of Albania and Switzerland and the President of the International Committee of the Red Cross. Delegates are asked to be in their seats promptly by 10:00.

11:00 - 13:00

1. Official opening of the meeting.

The 10MSP will be officially opened by Ambassador Susan Eckey of Norway, President of the Second Review Conference.

2. <u>Election of the President</u>.

The Second Review Conference agreed to designate, as President of the 10MSP, H.E. Gazmend Turdiu, Secretary General of the Ministry of Foreign Affairs of the Republic of Albania.

3. <u>Brief messages delivered by or on behalf of Nobel Peace Prize laureate Jody Williams, the President of the Council of Foundation of the Geneva International Centre for Humanitarian Demining and the Secretary General of the United Nations.</u>

In keeping with tradition at Meetings of the State Parties (MSPs), brief messages will be delivered.

4. Adoption of the agenda.

At the 25 June 2010 meeting of the Standing Committee on the General Status and Operation of the Convention, a draft agenda was presented. The Co-Chairs concluded that this was acceptable to the States Parties for adoption at the 10MSP.

5. Election of the Vice-Presidents.

In keeping with tradition at MSPs, the Co-Chairs of the Standing Committees will be nominated to serve as Vice-Presidents of the 10MSP, namely: Bulgaria, Ecuador, Greece, Indonesia, Nigeria, Peru, Slovenia and Turkey.

6. <u>Confirmation of the Secretary-General.</u>

In keeping with tradition at MSPs, the host country has nominated a Secretary-General, namely, Ambassador Jürg Lauber of Switzerland.

7. <u>Organization of work</u>.

At the 25 June 2010 meeting of the Standing Committee on the General Status and Operation of the Convention, a draft programme was presented. The Co-Chairs concluded that this was acceptable to the States Parties for adoption at the 10MSP.

8. General exchange of views.

Given the volume of work that must be dealt with at the Tenth Meeting, States Parties and observers are encouraged to refrain from making general statements but rather provide updates on implementation on thematic matters indicated in agenda item 12. In addition, if they wish, delegations can distribute written statements rather than deliver oral statements.

9. <u>Informal presentation of requests submitted under Article 5 and of the analysis of these requests.</u>

Requests for extensions of deadlines for the destruction of anti-personnel mines in mined areas in accordance with Article 5 have been submitted by Chad, Colombia, Denmark, Guinea-Bissau, Mauritania and Zimbabwe. Requesting States Parties should prepare presentations (6-8 minutes) on the key aspects of their extension requests. These presentations will be followed by the President of the Second Review Conference presenting an analysis of each request. All delegations will then have a chance to ask questions and make comments on each request. (The actual formal consideration of the requests will take place on Friday 3 December.) To prepare for this item, delegations may wish to review the requests that have been submitted.

Prak Sokhonn, Minister Attached to Prime Minister and Vice-Chair of Cambodian Mine Action and Victim Assistance Authority.
