## **Some Considerations**

- Law.

• The differential approach is a general principle in the Victims and Land Restitution

• An important challenge of the Unit has been to provide an effective and coherent response to the special needs of the victims with disabilities, so that they are attended to and repaired in conditions of full equality, that is, promoting accessibility in the measures of care, assistance and repair, both in our role as service provider and coordinator of SNARIV.

• The Unit has overcome the under-registration of victims with disabilities and victims of anti-personnel landmines (AP-mines):

• There are 393.243 victims with disabilities (4,3%) • There are 11.737 victims of AP-mines (0.12%)



## **Social Inclussion Strategy for Victims** with **Disabilities**

- The Unit has designed, has validated and is replicating this successful experience in which different sectors have agreed that awareness is the basis for promoting the social participation of victims with disabilities.
- In order to strengthen the skills of health professionals, teachers and staff in general who provide direct services to victims of the conflict, in the last 5 years there has been ongoing training that promotes understanding of the social model of disability, strengthening the accessibility of the sectors: Health, Education, Labor, Office of the High Commissioner for Peace and Ministry of the Interior.
- The actions developed in the different components of the Strategy respond to characteristics of municipalities whose context is rural, dispersed and with a low budget.
- It develops recommendations of the CRPD.
- It incorporates concrete actions aimed at promoting comprehensive reparation for victims with disabilities.
- Is based on the installed capacity of national and territorial entities, in order to enhance their results.




# **Operation Model with Differential and Gender Approach**
