

## **Current Situation**

#### 4 Northern Provinces

- Post clearance evaluation by the IND and local authorities indicated remaining EOD tasks that need further survey;
- Provincial committees to co-ordinate any residual clearance: to be carried out by the police.



## Goals of NMAP 2008-2012(14)

- Ensure coordination of the de-mining programme through monitoring, quality control and assurance, information management, advocacy and resource mobilisation.
- Clear all known mined areas, conduct surveys and clear all new identified areas.
- Consolidate all mine/UXO-risk reduction activities in affected communities, and update the country data base on mine victims.
- Strengthen mine action mainstreaming into Social and Economic Plans (PES) and ensure effective budgeting by all key development sectors.
- Ensure the sustainability of national capacity to deal with residual landmines and other Explosive Remnants of War (ERW).

### The Convention Deadline (Art.5) **Extension Request Process**

- Evaluation of 2002-2006 Plan indicated:
  - additional areas had been discovered and reported;
  - data was inaccurate and dimensions of affected areas were overestimated in the LIS;

  - Mozambique will not fulfill its obligation under article 5 by 2009.
- Impediment factors:
  - Overestimation of the mine problem;
  - Limited mine records;
  - Poor economic situation of the country;
  - Vast territory;
- Baseline assessment conducted;
  - record additional areas requiring clearance
  - update mine-fields database
  - to estimate dimensions of affected areas
  - define time-frame and resources required for clearance
- National Mine Action Plan 2008-2012(14) approved;
- Submission of the Extension Request for 5 year period, from March 2009 to March 2014.

## Rationale and Strategic Vision of the **Extension Request**

- Planned annual mine clearance based on existing technical capacity:
- Realistic estimated annual financial support;
- Co-ordinated deployment of demining assets as per priorities, among all mine action implementing partners;
- · Clear roles and responsibilities of all stakeholders putting communities at the centre;
- · Stipulated monitoring mechanism to consolidate efforts and assess accomplishment of objectives;
- Overall Government commitment to achieve its obligations under the convention regardless of any potential constraints that may arise.

#### Present Challenges

- Insufficient flow of resources to MA sector;
- Mine problem should be properly addressed as a development issue by all stakeholders;
