What measurable improvements have been made in the well-being and guarantee of the rights of mine victims since the adoption of the Maputo Action Plan?

Jordan has succeeded the adoption of a new approach based on participatory management, accountability and transparency as well as changing the care approach to the rights-based approach, Through the promulgation of the new law on the rights of persons with disabilities, which entered into force on 8/2017. In addition to working on two tracks: first holistic level in terms of policy and national strategy on the rights of persons with disabilities, and the second track on Victims' assistance programmes in accordance with the provisions of the mine ban Convention and the recommendations of the Maputo plan. In 2018, HCD developed four plans that address the themes of inclusive education, accessibility, independent living and awareness-raising plan

- 1. In terms of accessibility, the updated version of the Jordanian Building Code and Code was launched. Within three years, four model areas will be operated in Amman, Irbid and Aqaba, Petra and in collaboration with the Ministry of Works, The Ministry of Tourism, the Ministry of Municipalities, the Greater Amman Municipality and the authority of the Aqaba Region. On Monday 11 March 2018, Jordan launched the National Plan for Correcting Existing Buildings and Public Facilities 2019-2029. The plan aims to rehabilitate 60% of the public facilities and buildings that serve the public by 2029, by applying the criteria of construction requirements for persons with disabilities or finding suitable alternatives as appropriate. To date, work finished in 2 areas: Jordan University and Jabal Amman area.
- 2. In the plans for inclusive education, over the next three years, 75 schools will be rehabilitated for inclusive education in terms of training of cadres and rehabilitation of facilities, infrastructure and the school environment.
- 3. The Independent Living Plan has been handed over to the Ministry of Social Development.
- 4. Standards of accreditation and diagnosis are ready. Diagnostic centers will be accredited by the Ministry of Health. Licenses will also be issued for sign language and legal translation.
- At the level of awareness raising; awareness campaigns have been launched on all social media and produced a number of films dealing with accessibility, early intervention, inclusive education, the right to work and independent living. The Tourism Promotion Authority and the Banks and Ministries Sector were trained on the new law.
- On Monday 11 March 2018, Jordan launched the National Plan for Correcting Existing Buildings and Public Facilities 2019-2029. The plan, according to the HCD, aims to create 60% of the public facilities and buildings that serve the public by 2029, by applying the criteria of construction requirements for persons with disabilities or finding suitable alternatives as appropriate.

Assessment of needs, the availability and gaps in services (Action #12)

3. At present there is no system to assess the availability and gaps in services, and the referral to services is being facilitated by the victim assistance coordinator of the National Committee for Demining and Rehabilitation (NCDR). NCDR remains responsible to update the Victims national record and collect data on new casualties (the method of collecting date is done by home visits to every victim), also works on updating a needs assessment survey that was previously done. This year, NCDR launched a new VA project that aims to identify the needs, and directly cover the most pressing needs in accordance. Also, the data-base was redesigned and finished in February 2019(A copy was shared with ICBL).

Time-bound and measurable objectives (Action #13)

4. The Committee noted that Jordan had integrated victim assistance in its 2015-2020 NCDR National Plan outlining activities in areas of coordination, rehabilitation, and economic reintegration. Jordan has also reported and shared a copy of the 2017 Law (No. 20) on the Rights of Persons with Disabilities which guarantees the rights of all persons with disabilities. In 2019, NCDR allocated USD 170,000 for VA.

Enhancement in the integration of victim assistance into broader frameworks, including allocation of budgets for their implementations (Actions #14)

- 5. Integration of victim assistance into broader frameworks relating to the needs and rights of persons with disabilities, including through:
 - a) Making victim assistance an integral part of the country's five-year National Strategy for Persons with Disabilities, and;
 - b) Including victim assistance in the Law on the Rights of Persons with Disabilities, as an effort to guarantee the rights of survivors to health care services, rehabilitation, work, and education.
 - c) To ensure that all activities are inclusive and appropriate for all beneficiaries, A steering committee formed in 2019, including the Higher Council for the Affairs of People with Disabilities (HCD), the Agricultural Credit Corporation (ACC), the Hashemite Commission for Disabled Soldiers (HCDS) and life Line for Rehabilitation and Consultation (LLCR).
- 6. A budget of \$170,000 is allocated by NCDR's National Plan for the implementation of victim assistance in 2019. The main key objectives of the project are:
 - a. Advocate and Increase awareness for the rights and the available services for survivors and people with disabilities
 - b. Data Collection and needs assessment
 - c. Enrich Education, socio-economic reintegration and psychological support

Increase availability of and accessibility to rehabilitation services, economic inclusion opportunities and social protection measures for all mine victims, regardless of their gender and age (Action #15)

7. Accessibility to rehabilitation services is available to everyone who has medical insurance; and for those who don't have, the VA coordinator at NCDR deal with each

case separately to secure free medical care when needed. Regarding economic inclusion opportunities, NCDR used the provision of small loans (of \$4,200) in cooperation with Agricultural Fund to create income-generating projects that improve civil mine/ERW victims 'economies. NCDR continues (doubled the number of beneficiaries in 2019) to provide monthly financial support to mine/ERW victims through the Office of the Crown Prince according to the urgent needs and priorities. This year, NCDR is seeking to establish an integrated agricultural project within the areas where there is the largest gathering of the Victims. The project will be financially supported by the NCDR after obtaining authorization to use the proposed agricultural lands from the government. The idea is Working together with ministries and institutions to launch a pilot project on a mine cleared land to make an example in the region and Mine Action programs globally. All financial return will be used in full in the VA programming. In addition, Vocational training workshops will be on the agenda of the Victims' assistance Project.

Strengthen local capacities and enhance coordination (Action #15)

Inclusion and participation of mine victims (Actions #16)

9. Victims had actively participated when the NCDR implemented victim assistance projects. This year (2019), NCDR, developed a working group consisting of 4 landmine/ERW survivors from deferent regions, so that they will continue to be involved in all activities. NCDR would also be very excited to support networking and initiate beneficiary led program if the interest from beneficiaries is expressed.

Removing barriers and raising awareness (Actions #15 and #17)

10. At the national level of awareness raising; in 2018, awareness campaigns have been launched and continuing on all social media and produced a number of films dealing with accessibility, early intervention, inclusive education, the right to work and independent living. Also, NCDR will ddevelop and print manuals or brochures on the new law on rights of PWDs and the access to available services including referral systems where possible. These will be disseminated and discussed through meetings with victims and camps during 2019

Measurable improvements, challenges, and priorities for assistance in advance of the next Review Conference (Action #18)

11. Jordan's key challenge is the lack of funding for victim assistance programme. More information will be provided by the end of 2019 after the revision of NCDR's MA plan.
