[Narrative:] The National Demining Personnel under took a general mine action assessment and were able to identify two mined areas in Kitgum district; thus Agoro hills and Ngomoromo. Agoro hills comprised of 6 smaller mined areas which are approximately 130,000 SQM containing mainly Type 72 APMs, Ngomoromo mined area is a 4 kilometre long and 35 meter deep linear containing PMD6, No 10,PPM57 and type 72 APM. This area is approximately 140,000 SQM.

Clearance at Agoro hills is going still going on, two of the six areas have to date been cleared using manual clearance system, a total of 36 APMs Type 72 have been destroyed. On the other hand clearance all the 140,000 SQM have been cleared at Ngomoromo using a mine wolf machine provided by the Norwegian Peoples Aid (NPA), a quality assurance/quality control exercise is going on in the cleared area before the land can be handed over to the community in Agust 2010.

[Narrative / reference to other reports:]

While Uganda's Article five clearance dead line was August 1st 2009, it was un able to meet this dead line due to the late commencement of demining operations and poor weather conditions. Never the less, Uganda requested for an extension of the de-mining period to August 2012, this request was granted at the second review meeting held at Cartagena in 2009. Uganda is now putting all mechanisms in place to ensure the new dead line is met. The strategies adopted include the use of the mechanical means to clear the Ngomoromo area, which is being done and the increase in de-mining personnel by additional personnel, to scale up manual demining operations, this has been done in partnership with Danish Demining Group, supported by donors; Australia, Norway and Denmark.
