

Convention on the Prohibition of the Use, Stockpiling, Production and Transfer of Anti-Personnel Mines and on Their Destruction

On 1 March Convention partners gathered around the world to commemorate 20 years of action towards a mine-free world. Convention President Norway, hosted events at United Nations in Geneva and New York with among others the High Commissioner for Human Rights, UNICEF and UNHCR.

In Geneva, **Human Rights High Commissioner Michelle Bachelet** spoke of the importance of the Convention and its approach to victim assistance which "has shown unambiguously how an international convention can result in greater respect for, and protection of, fundamental rights. Its human rights-based approach is key part of its legacy", she said. Over 30 delegations participated in the event.



Convention friends also faced the cold and wind at an open air ceremony before the iconic *Jet d'eau* in Geneva. The fountain was illuminated in blue to commemorate 20 years of action, remember those fallen victim to mines and recall the work that remains to be done to achieve the mine-free ambition.

Participants included the Mayor of the City of Geneva, and Ambassadors and representatives of Austria, Bangladesh, Chile, Colombia,



Germany, Iraq, Japan, Mexico, Norway, Poland, Switzerland, ICRC, ICBL, UNICEF, UNMAS, UNODA, and the Convention on Cluster Munitions' Secretariat.

Norway has announced it will provide NOK60 million (over €6 million) to Sri Lanka via partners HALO Trust and NPA. "This year, Norway holds the presidency of the Mine Ban Convention, and intends to help Sri

On 26 February, Norway led the Fourth Pledging Conference opened by H.E. Audun Halvorsen, Deputy Minister of Foreign Affairs; 41 delegations participated including 31 States Parties. Chile

Chile has announced that in 2018 it had destroyed 6,310 anti-personnel mines representing 88.66% of completion rate. In addition, <u>the National Demining Commission (CNAD</u>), in coordination with the Canine Training Brigade of the Investigation Police, carried out for the first time technical demining work with mine detection dogs in the Arica region bordering with Peru. The Joint Chiefs of Staff, Vice Admiral Rodrigo Álvarez and CNAD's Executive Secretary Col. Andrés Cáceres congratulated Battalion Commanders and Humanitarian Demining Units for their work. Colombia

The Convention's ISU Director met in Bogotá with national authorities and relevant organisations to support Colombia in the process of



developing a request to extend Colombia's mine clearance deadline. Late in 2018, the mine action programme was relocated to the Office of the High Commissioner for Peace, Miguel Ceballos, featured here with Martha Hurtado the new Director of the Colombian mine action programme Descontamina.

South-South Cooperation: Peru-Chile

A team of CONTRAMINAS and the Peruvian Army's Humanitarian Demining Unit visited mine clearance operations in the highlands of the Arica and Parinacota, and Quebrada Escritos regions in Chile, to learn more about manual and mechanical demining procedures and equipment used in these particularly arid border regions.

On 27 March Cambodia <u>submitted a</u> <u>request to extend its mine clearance</u> <u>deadline</u>. The Cambodia Mine Action and Victim Assistance Authority (CMAA) was supported in the request process by UNDP, ISU and other stakeholders.
